



Transit Agencies Leading the Transition to ZEBs

What is ZEBRA?

The Zero Emission Bus Resource Alliance (ZEBRA) is a professional association for transit agencies in the U.S. and Canada to share lessons learned about zero-emission buses (ZEBs).

ZEBRA is a group of transit leaders exchanging information without the involvement of manufacturers or outside groups. Since 2015, the association has been providing members access to peer information and shared research.

In FY2023, ZEBRA welcomed 23 new members, launched an updated member KPI dashboard, and held two in-person roundtable events.

Engagement Opportunities

In addition to web meetings and the ZEBRA member portal, ZEBRA members have a variety of in-person opportunities to engage with peers, vendors, and industry experts throughout the year.

One-on-One:

ZEBRA was introduced to 25+ prospective agencies through One-on-One, a speed networking event hosted by the Center for Transportation and the Environment.

A Diverse Group of Peers

ZEBRA represents the collective voice of over 73 transit agencies. Our members represent:

- 586+ ZEBs in service
- 1200+ ZEBs in procurement
- 42 ZEB Transition Plans
- 5 hydrogen refueling stations
- 9 upcoming hydrogen refueling stations

2023 Bus OEM Roundtable:

ZEBRA, in partnership with the APTA Mobility Conference in Minneapolis, hosted a Bus OEM Roundtable in April 2023. Six bus OEMs spoke on current offerings and future plans for battery-electric and fuel cell electric buses.

2023 Energy Management Roundtable:

ZEBRA, in partnership with Montgomery County, Maryland, hosted an energy management roundtable in July 2023. Eight sponsors spoke on charge management, operational innovations, and microgrids for zero-emission fleets.

ZEBRA Advocacy

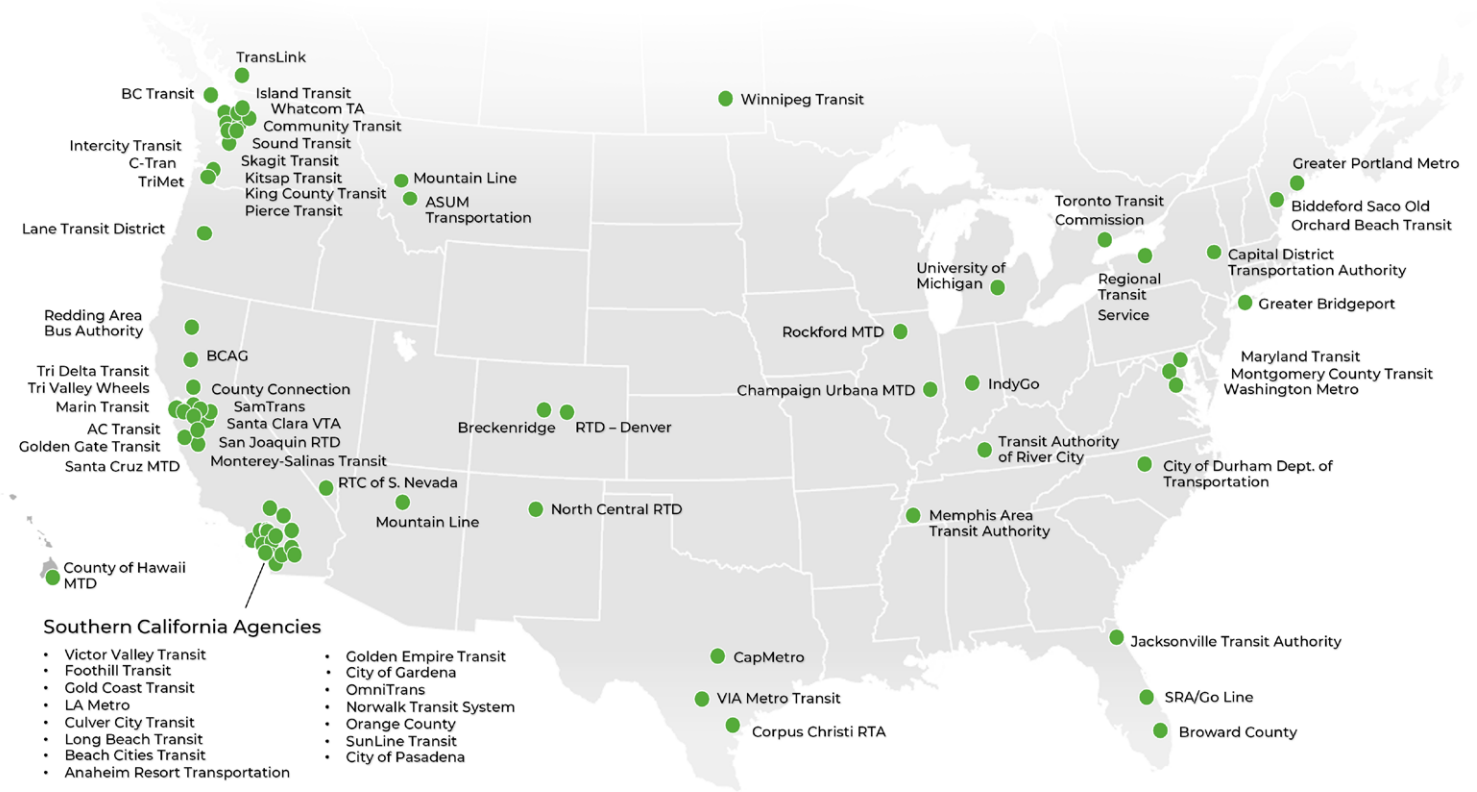
ZEBRA catalyzes its members' interests into a cohesive voice for effective ZEB policies at both the federal and state levels.

73 Members as of August 2023

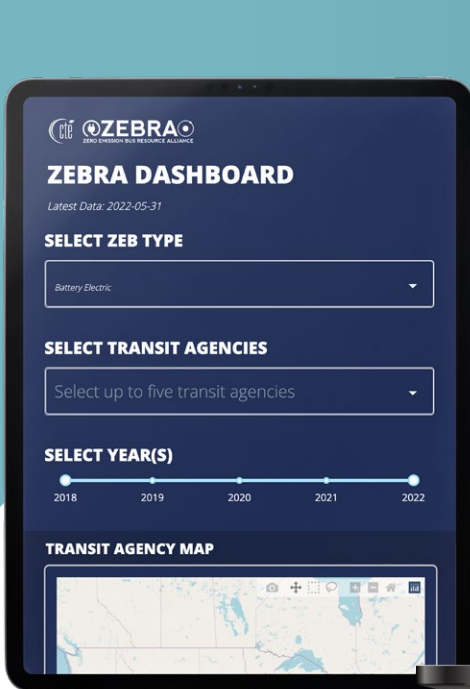
